#### BACKGROUND/DISCUSSION:

The Sacramento Metropolitan Cable Television Commission (Commission) is funded primarily with franchise fees and Public, Education and Government (PEG) fees collected from a percentage of the gross revenues of the cable television companies (AT&T, Comcast, and Consolidated Communications) operating in Sacramento.

The General Fund (094A) operating budget funds the two divisions of the Commission – Administration & Metro Cable - and supports six PEG channels operated by four Channel Licensees (Access Sac, KVIE, Sacramento Educational Cable Consortium, and Sacramento Faith TV). The balance of the franchise fee revenue minus operational costs is distributed annually to the Commission's seven member agencies, which includes the County of Sacramento and the cities of Citrus Heights, Elk Grove, Folsom, Galt, Rancho Cordova, and Sacramento.

The PEG Fee Fund (094B) funds Public, Education and Government (PEG) projects for the Commission's Member Agencies, Channel Licensees, and Metro Cable 14.

The Fiscal Year 2015-16 Proposed General Fund & PEG Fee Fund Budgets were developed to maintain the current level of core services which include:

- 1) Administering state-issued cable television state franchises in Sacramento County;
- 2) Assisting consumers in resolving their cable/video issues and concerns;
- Operating Metro Cable 14, the local government channel;
- 4) Supporting community programming of six PEG channels on the local cable system, operated by Access Sacramento, KVIE, Sacramento Educational Cable Consortium, and Sacramento Faith TV;
- 5) Collecting and distributing franchise fees to member jurisdictions;
- 6) Collecting PEG fees to fund PEG facilities and projects.

#### FISCAL YEAR 2015-16 GENERAL FUND BUDGET (094A)

The Fiscal Year 2015-16 Budget for the General Fund (094A) proposes \$13,787,005 in expenditures to be funded with \$13 million of projected Franchise Fee revenue and the balance of carryover funds from Fiscal Year 2014-15, plus other miscellaneous revenue.

The Commission's General Fund budget is divided into five major components:

#### **COMPONENT 1 - ADMINISTRATION AND REGULATION**

This is the franchise administration and enforcement arm of the Commission. The part-time Executive Director serves at the pleasure of the Commission. The Administration Division is currently staffed with two full-time employees – an Administrative Services Officer III and a Senior Office Assistant. An additional full-time Senior Office Assistant position approved by the Board in Fiscal Year 2012-13 is currently unfilled. At this time, staff is recommending an Administrative Services Officer I be budgeted in place of the additional Senior Office Assistant position previously approved. The higher position is needed to address the amount and level of confidential administrative and budget work required of the administrative staff. Also, with a two-person office and a part time Executive Director, this position is necessary in order to have sufficient segregation of duties as well as for succession planning.

All of the Commission positions are tied to Sacramento County's salary adjustments (including COLAs and equity adjustments) approved for certain County positions. It is anticipated a 2% COLA will be applied to the County positions that the Commission positions are tied to for Fiscal Year 2015-16. It is also anticipated that additional salary adjustments between 1% and 1.9% will be applied to those County-tied positions.

#### COMPONENT 2 - CLOSED CAPTIONING

Closed captioning was implemented in June 2006 with Board direction to caption the Commission's JPA member agency meetings and other agency meetings held in the County Board of Supervisors Chambers. For Calendar Year 2014, 319 meetings were closed captioned with 606.5 meeting hours closed captioned by Caption Colorado. The FY 2015-16 budget proposes \$110,000 in funding for closed captioning services. Staff is recommending the Caption Colorado Agreement be renewed another year through June 30, 2016, with the same terms and conditions as the original 2006 Agreement.

#### COMPONENT 3 - METRO CABLE

The Metro Cable budget includes salaries and wages for four (4) full-time employees, including a Production Director, a Program Coordinator, a Technical Coordinator, and a Production Assistant III, as well as nine (9) part-time Production Assistants.

Metro Cable is responsible for cablecasting local government meetings and provides gavel-to-gavel coverage of meetings held by the Commission, its seven member agencies, and thirteen other agencies (including eight agencies that meet in the County Board chambers and offsite meetings for four contracted agencies). In addition, Metro Cable staff supports the member agencies by providing assistance with equipment maintenance and testing, quality oversight, as well as recommend equipment to upgrade council chambers and control rooms for PEG Fee funded projects.

#### COMPONENT 4 - COMMUNITY PROGRAMMING (CHANNEL LICENSEES' OPERATIONS BASE)

The Commission provides funding and support for three of its four Channel Licensees - Access Sacramento, KVIE, Sacramento Faith TV, and the Sacramento Educational Cable Consortium – that operate six of the Commission's seven PEG channels available to the community on the local cable systems; the Commission operates Metro Cable 14. Capital Public Radio also receives funding from the Commission.

As was done in the last five years, funding requests submitted by Channel Licensees were segregated into two categories – operational versus facilities & equipment costs. Operational costs are to be funded by the General Fund; facilities/equipment are to be funded by the PEG Fee fund. The benefit of this strategy is that it moves the facilities and equipment funding from the General Fund to the PEG Fee fund, thereby reducing expenditures from the franchise fees revenue, thus maximizing the revenue distribution to the Commission's seven member agencies. For this year, KVIE has requested that its operations base be moved back into the General Fund. During the downturn, KVIE moved its *entire* base into the PEG Fee Fund, thereby providing help to member agencies in increasing the revenue distribution. KVIE is making this request because of the slow economic recovery and its effect on KVIE's operating revenue.

Commission staff reviewed the Channel Licensees' funding requests. The following table identifies the proposed General Fund funding for Channel Licensees' Operations Base, which includes a recommendation of a 4% COLA for FY 2015-16. The Board approved a 2% COLA for the Base in FY 2014-15. The proposed funding also includes a grant of \$8,226 for Capital Public Radio for digital audio equipment.

Per past practice, Channel Licensees' funding request for additional items are forwarded to the Board for review at its annual budget hearing process and funding is granted on a case-by-case request.

The Fiscal Year 2014-15 Revenue Distribution to Member Agencies to be distributed in June 2015 will be \$11.5 million (an increase of \$1,165,432 over the amount budgeted due to the difference in the actual franchise fees received (\$13,665,431) compared to the amount budgeted (\$12,500,000)). The proposed revenue distribution for Fiscal Year 2015-16 is \$10.7 million and will be distributed to member agencies in June 2016 and is based on \$13,000,000 in anticipated franchise fee revenue.

#### FISCAL YEAR 2015-16 PEG FEE FUND BUDGET (094B)

In 2009, the Commission Board adopted Resolution No. 09-001, determining to implement and collect a fee to support PEG channel facilities in the amount of one percent (1%) of gross revenues. Collection of the PEG Fee was implemented in May 2009 for State cable/video franchisees operating within the Commission boundaries (AT&T, Comcast, and Consolidated Communications). The PEG Fee Fund (094B) was established in Fiscal Year 2010-11, to account for PEG fees separate from Franchise fees in the Commission's General Fund (094A).

Since federal law restricts the use of PEG funding to capital facilities and equipment costs, the Commission's Legal Counsel developed the working definition of the types of expenses that qualify for the use of PEG Fee funding. The guidelines were provided to all Member Jurisdictions and Channel Licensees that request and receive PEG Fee funding.

#### **DISCUSSION/ANALYSIS:**

The proposed Fiscal Year 2015-16 PEG Fee Budget is based on \$2.6 million of PEG Fee revenue, with expenditures of \$3,062,500. The budget includes an estimated \$460,000 of FY 2014-15 carryover funds.

The Commission's Member Agencies and Channel Licensees were advised of available funding for PEG facilities and equipment and asked to submit a funding request for Fiscal Year 2015-16 to the Commission. Staff recommends the Board approve, as to form, the Fiscal Year 2015-16 Funding Agreement prepared by Legal Counsel, and authorize the Executive Director to prepare and modify the agreement as needed for each agency based on the approved funding amounts determined.

In addition, Legal Counsel prepared a Fifth Amendment to Channel Licensee's Licensee & Operations Agreements, which extends the Agreement through June 30, 2016.

Exhibit 3 provides a summary of the Fiscal Year 2015-16 funding proposal for all PEG projects, including those of Member Agencies, Metro Cable/Administration, and Channel Licensees.

#### PEG Fee Funded Projects for Member Agencies

Since its inception, the PEG Fee fund has been used to fund many projects for the Commission's seven member agencies. Metro Cable staff continues to assess member agencies' needs on an annual basis for control room and Board Chamber upgrades. For Fiscal Year 2015-16, they reached out to the member agencies to provide input of PEG equipment and facility needs.

The proposed funding for identified PEG facilities/equipment projects for each member agency is included in the Fiscal Year 2015-16 PEG Fee Fund budget. The table below identifies PEG funding proposed for each member agency, based on the submitted requests, which include Metro Cable staff recommendations. These requests are mostly for control room audio video upgrades and board/council chambers improvements. The improvements are summarized in Exhibit 3.

#### PEG Fee Funded Projects for Channel Licensees

In addition to the annual base requests, Channel Licensees submitted the request(s) for one-time equipment funding from the PEG Fee Fund. Staff reviewed the Channel Licensees' funding request (Attachments 22-25) insure all requests fit within the definition of expenditures that may be funded by the PEG Fees.

KVIE's request include equipment related to facility improvements, production/content creation, signal delivery and network facilities.

SECC's request includes the fifth year of the BESTNet Phase III funding (\$600,000), SEVA studio labs which SECC plans to leverage with other funds to provide multiple labs, and production equipment.

Access Sacramento's request includes various computer, software, audio/video, storage, and studio equipment. In addition, ACCESS Sacramento is requesting funding for a truck (\$706,875). The request is for an HD video truck capable of shooting a wide variety of indoor and outdoor events including Game of the Week and Hometown TV productions. This request has been discussed in previous years and last year's budget included \$15,000 for a truck integration plan which ACCESS Sacramento had prepared this year. Given the size of this requests, staff asked Gary Martin, Executive Director of Access Sacramento several questions including whether they looked at alternatives and were there going to be additional costs for operation, maintenance, insurance and security. Mr. Martin indicated that this was the less expensive of two quotes and the TV Pro Gear proposal is the least costly alternative that meets the minimum acceptable technical and operational needs of the station. He also indicated that operations costs would not be significant but possible software and equipment updates in the future are not known at this time. Mr. Martin has also requested a quote from his insurance company which is not available at this time but he will have it on hand to share at the meeting. In regard to storage and safety, he indicated that the truck is strongly secure itself and will be stored in an existing storage space behind a 12-foot fence topped with razor wire with a gate secured by multiple chains and locks.

The proposed Fiscal Year 2015-16 PEG Fee funding includes a 4% COLA to the Capital Equipment/Facilities Base.

2. Payment Contingent on Receipt of PEG Fees. Member Agency understands that the funding amount set forth in Section 1 will be made to Member Agency solely out of PEG fees collected by SMCTC from cable television operators. Such PEG fees are received in quarterly payments and SMCTC shall be under no obligation to pay to Member Agency the amount stated in Section 1, or any other amount, unless SMCTC receives sufficient PEG fees to make such payment. If actual revenue received through PEG Fees is less than anticipated, SMCTC is not obligated to pay Member Agency. Payments to member agency will occur during the fiscal year and will be prioritized by the SMCTC based upon facility needs and available revenue; Member Agency will be reimbursed based on actual expenditures.

Member Agency further understands that SMCTC may enter, or has already entered, into similar funding agreements with other member agencies and with channel licensees that operate one or more of the SMCTC PEG channels. In the event SMCTC receives some, but not all of the PEG fees necessary to fund all such funding agreements, each member agency and channel licensee shall receive available PEG funds based on the criteria set forth above. If there are insufficient PEG fees to satisfy all funding requests during this fiscal year, members agencies not receiving all identified funding shall be entitled to a higher priority in the next fiscal year before any funding for new projects for the next year fiscal year is approved.

3. Use of PEG Fee funding. Member Agency understands that the funding provided to it pursuant to this Agreement originated from PEG access channel fees. As a condition of accepting the PEG Fee funding, Member Agency agrees to use those funds only for capital expenditures and facilities related to the provision of cablecasting on the PEG channels and for no other purpose. SMCTC has both the responsibility and the right under this Agreement to monitor and audit the use of the funding allocated under this Agreement. Member Agency shall agree to cooperate fully with any audit requested by SMCTC.

Since applicable law does not specifically define those expenses that qualify as capital costs, SMCTC has developed a working definition of the types of expenses that it believes qualify for the use of PEG Fee funding. SMCTC reserves the right to modify its working definition as the law on this topic develops. In accordance with SMCTC's working definition, PEG Fee funding may be used for the following expenditures: purchase of equipment, rental of facilities, purchase of software, and tangible goods provided that a CPA certifies that the tangible goods qualify as capital expenditures pursuant to standard accounting practices. PEG Fee funding may not be used for the following expenditures: operations, training, maintenance, employment of staff, and hiring of persons to perform services. Member Agency shall provide for such fiscal control and funding accounting procedures as reasonably necessary to assure proper disbursement, accounting, and expenditures of PEG Fee funding.

Member Agency further understands and agrees that the PEG Fee funding provided by SMCTC was awarded based on a request from Member Agency and that the use of the PEG funds are limited to the expenditures outlined in that request as approved by SMCTC. If Member Agency determines that it will not proceed with the expenditures as set forth in the request approved by SMCTC during the current fiscal year, then Member Agency shall notify SMCTC that the Member Agency will re-submit the PEG Fee funding in the next fiscal year. The Member Agency may also request to modify the approved use of the funding. The Executive Director may consider and approve requests up to a total of \$50,000 in the fiscal year if the requested change(s) is an allowable PEG Funding expenditure. Requests above a total of \$50,000 will require Commission consideration and action. The Executive Director may consider and approve any request as authorized by this section. The Executive Director may also elect to seek direction or action by the Commission on any such requests.

4. Indemnification. Member Agency shall, at its sole expense, fully indemnify, defend and hold harmless SMCTC and its member agencies, and in their capacity as such, the officers, agents and employees thereof, from and against any and all claims, suits, actions, liability and judgments for damages including reasonable attorneys' fees or otherwise.

For actual or alleged injury to persons or property, including loss of use of property due to an occurrence, whether or not such property is physically damaged or destroyed, directly or indirectly arising out of or attributable to, in whole or in part, the acts or omissions of Member Agency in connection with, related to, or in any way arising out of Member Agency's use of the PEG Fee funding provided to it under this Agreement.

Directly or indirectly arising out of or attributable to, in whole or in part, Member Agency's failure to comply with the provisions of any statute, regulation, or ordinance of the United States, the State of California, SMCTC or any local agency in connection with, related to, or in any way arising out of Member Agency's use or expenditure of the PEG Fee funding provided to it under this Agreement.

- 5. Attorneys' Fees. If any party to this Agreement commences any legal action against another party to this Agreement which arise out of this Agreement or the performance thereof, the prevailing party in such action may recover its reasonable litigation expenses, including court costs, expert witness fees, discovery expenses and attorneys' fees.
- 6. Reimbursement Requirement; Record Retention. No later than sixty (60) days after incurring expenses to be reimbursed by funds provided to it under this Agreement, Member Agency shall submit to SMCTC a copy of all invoices and receipts reflecting the expenditures made with such funds, a request for reimbursement from funds identified in Section 1 above and such other

information as SMCTC may require. SMCTC shall reimburse Member Agency within a reasonable time of receipt of such documentation subject to the provisions of this Agreement, including Sections 2 and 3. Member Agency shall retain all records related to the expenditure of PEG Fee funds for a period of no less than three (3) years from the last expenditure reimbursed under this Agreement.

- 7. Unauthorized Use of PEG Fee funding. If SMCTC determines that Member Agency has used the PEG Fee funds provided to it under this Agreement for purposes other than capital expenditures and facilities, Member Agency shall return to SMCTC the total sum of those unauthorized expenditures within sixty (60) days of receipt of written notice from SMCTC.
- 8. Ownership of Facilities and Equipment. Member Agency shall own and be solely responsible for any facilities, equipment, or other items that it acquires with PEG Fee funding provided to it pursuant to this Agreement. SMCTC shall have no obligations, and shall bear no costs, with respect to any facilities, equipment, or other items that Member Agency acquires with such PEG Fee funding.
- 9. No Right of Action. Member Agency understands and agrees that it has no right of judicial action against SMCTC for the failure of SMCTC to pay any or all of the funds to Member Agency under this Agreement. Such judicial actions include those at law and/or equity, including, but not limited to, any action to compel payment of the funds, any action for general or special damages, or otherwise.
- 10. Agreement Contains All Understanding. This document represents the entire and integrated agreement between the Parties, and supersedes all prior negotiations, representations or agreements, either written or oral regarding the subjects addressed herein. This document may be amended only by written instrument, signed by all Parties.
- 11. Effective Date of Agreement. This Agreement shall be effective on the date next to the signature of the Executive Director of the SMCTC, as authorized by the SMCTC Board on the 5<sup>th</sup> of June 2014.
  - 12. Terms. The term of the PEG Fee funding Agreement ends June 30, 2016.

THIS AGREEMENT is between the Sacramento Metropolitan Cable Television Commission ("SMCTC") and (INSERT CHANNEL LICENSEE NAME HERE) ("Licensee"). - A. SMCTC and Licensee have entered into the Licensing Agreement. The Licensing Agreement provides Licensee the right to use one (or more) cable television channels which SMCTC controls for television programming which is beneficial to the public, subject to certain terms and conditions.
- B. The purpose of this Funding Agreement is to provide certain funds to Licensee for the purpose of operating the cable television channel(s) licensed to it under the Licensing Agreement, except to the extent that those funds originate from public, educational, and governmental (PEG) access channel fees, since the use of those PEG funds is restricted as set forth in Section 4 of this Funding Agreement.
- C. SMCTC has received a proposal from Licensee for funding. SMCTC hereby approves the proposal as modified based on review by Legal Counsel of eligible PEG equipment/facilities, and as approved by the Board. A copy of the Licensee proposal which is in the possession of SMCTC is hereby incorporated by this reference.

#### WHEREFORE, THE PARTIES AGREE:

- 2. Licensing Agreement. In addition to operating in accordance with the approved proposal, Licensee agrees to be bound by all terms and conditions of the Licensing Agreement, which are incorporated by this reference, as though they were fully set forth herein. A breach of the Licensing Agreement shall automatically be considered a breach of this Funding Agreement and vice versa.
- 3. Payment Contingent on Receipt of Fees. Licensee understands that the amount specified in Section 1 will be paid to Licensee out of the franchise and/or licensing fees and/or PEG fees collected by SMCTC from cable television operators. SMCTC shall be under no obligation to pay to Licensee the amount stated in Section 1, or any other amount, unless SMCTC receives sufficient fees to make such payment. Licensee further understands that other licensees may, or have, submitted proposals for operation of the channel(s) licensed to them and that SMCTC may, or has, approved such proposals, and that SMCTC may sign, or has signed, funding agreements with them.

In the event SMCTC receives some, but not all, of the fees necessary to fund all funding agreements, each licensee shall receive its *pro rata* share of the available funds based on the percentage each individual licensee's approved dollar amount under its funding agreement bears to the total dollar amount of all funding agreements.

4. Use of PEG Fee Funding. Licensee understands that a portion of the amount specified in Section 1 may be paid to Licensee from money that originated from public, educational, and governmental (PEG) access channel fees, which portion, if any, is reflected in the table in Section 1(a). As a condition of accepting PEG fee funds, Licensee agrees to use those funds only for capital expenditures and facilities and for no other purpose. Licensee shall provide for such fiscal control and funding accounting procedures as reasonably necessary to assure proper disbursement, accounting, and expenditure of PEG fee funds. Notwithstanding Licensee's acceptance of PEG fee funds, Licensee shall be subject to all of the provisions of the Licensing Agreement, including reporting requirements, except those provisions that conflict with this Section 4 with respect to the use of PEG fee funds. At SMCTC's discretion, PEG fee funds may be disbursed to Licensee upon SMCTC's receipt of invoices from Licensee for qualifying expenditures.

Since applicable law does not specifically define those expenses that qualify as capital costs, SMCTC has developed a working definition of the types of expenses that it believes qualify for the use of PEG Fee Funding. SMCTC reserves the right to modify its working definition as the law on this topic develops. In accordance with SMCTC's working definition, PEG Fee funding may be used for the following expenditures: purchase of equipment, rental of facilities, purchase of software, and tangible goods provided that a CPA certifies that the tangible goods qualify as capital expenditures pursuant to standard accounting practices. PEG Fee funding may not be used for the following expenditures: operations, training, maintenance, employment of staff, and hiring of persons to perform services.

Licensee further understands and agrees that certain of the PEG Fee funding provided by SMCTC was awarded based on a request from Licensee and that the use of the PEG funds are limited to the expenditures outlined in that request as approved by SMCTC. If Licensee determines that it will not proceed with the expenditures as set forth in the request approved by SMCTC during the current fiscal year, then Licensee shall notify SMCTC if the Licensee would like to re-submit the PEG Fee Funding in the next fiscal year.

The Executive Director shall consider and may approve any request for an extension to the next fiscal year pursuant to this section. Any request beyond the next fiscal year shall be submitted to the Commission for its consideration. Further, Licensee may determine that it has critical or pressing needs that it would prefer to direct the funding towards than the approved request. Should such occur, Licensee may submit such a request, in writing, to the Executive Director with the rationale for this request. The Executive Director may consider and approve the request provided that he/she determines that (1) it is the type of expenditure that would have been eligible for PEG Funding, (2) the need expressed is critical or pressing and (3) the amount does not exceed \$50,000 dollars. Any request above this amount must be approved by the Commission Board.

The Executive Director may also elect to seek direction or action by the Commission Board on any requests made pursuant to this section. Neither the Executive Director nor the Commission Board is required to approve any request for modification made pursuant to this section. If the request is not approved and the Licensee does not use the funds for the purpose and within the time frames, as approved by the Commission, such funding approval shall be cancelled and may be reallocated as the Commission deems appropriate.

If Licensee is able to complete an approved PEG Fee project for less than the approved PEG Fee funding, the Licensee may so notify SMCTC and request that the Licensee be authorized to retain the allocation of PEG Fees not required for a future project that would be otherwise eligible for PEG Fee funding. Such request shall be approved by the Executive Director provided that the Licensee has completed the approved project and agrees to use the remaining funding for an eligible project within the then current or the next fiscal year. Funds not used within the next fiscal year shall be remitted to the SMCTC or will be deducted from future approved allocations.

- Re-payment of Remaining Funds on Demand; Freezing Expenditures. understands that pursuant to the Licensing Agreement, its license may be revoked or terminated under certain conditions. Licensee agrees that if its license is revoked or terminated it will, immediately upon demand of SMCTC, pay to SMCTC any and all amounts then held by it from the funds provided to it by SMCTC under this Funding Agreement. Licensee further agrees that SMCTC may, at any time, order Licensee to cease, and Licensee shall cease, spending any of the funds provided to Licensee by SMCTC under this Funding Agreement in order for SMCTC to make a determination whether to revoke or terminate Licensee's license.
- No Right of Action. Licensee understands and agrees that it has no right of judicial action against SMCTC for the failure of SMCTC to pay any or all of the funds to Licensee under this Funding Agreement. Such judicial actions include those at law and/or equity, including, but not limited to, any action to compel payment of the funds, any action for general or special damages, or otherwise.
- Effective Date of Agreement. This Funding Agreement shall be first executed by the Licensee. It shall be effective on the date next to the signature of the Chair of SMCTC after the Chair has been authorized to execute it by SMCTC.
  - 8. Term. The term of the Funding Agreement ends June 30, 2016.

### New Request - DSP Upgrade, Camera Upgrade Installation, Sony Wall Mount Brackets: \$16,891.60

- DSP Upgrade per attached budgetary estimate from McWhirter AV of \$12,620 plus 10% contingency of \$1,262
- Camera Upgrade Installation per attached budgetary estimate from McWhirter AV of \$1,800 plus 10% contingency of \$180
- Sony Wall Mount Brackets per attached budgetary estimate from CDW of \$936 plus 10% contingency of \$93.60

Goal: To improve overall audio/video quality, experience and manageability by MetroCable and City Staff:

In response to your letter dated March 31, 2015 and on behalf of Sacramento County, I am submitting this request for consideration for the 2015/16 Public, Education, and Government (PEG) Funding. The following information outlines the issue and recommended solution.

Currently the Metro Cable 14 Broadcast is streamed live via the Internet, 24 hours per day, from a site that is integrated with Sacramento County's agenda management system. The current functionality has many limitations to the users and requires use of a Windows based computer with Internet Explorer, and a specific plug-in to view the live stream (SilverLight).

The attached proposal is to implement a system that will allow streaming of the Metro Cable 14 Live Broadcast to a broader range of users and devices. The new system will not limit streaming capabilities to a specific platform or browser requirements. Viewers will be able to stream the Metro Cable 14 Live Broadcast from any of the following devices:

- A computer or laptop running any type of browser including Internet Explorer, Safari, Chrome, Firefox, etc.
- A mobile device, smart phone or tablet including Apple, Android, and Windows devices.
- A Set Top Box such as Roku, Apple TV, and Chromecast.

The proposed cost estimate includes the hardware needed to implement the solution, shown in the Content Acquisition and Content Management boxes below, as well as a subscription service that will deliver multiple streams of the broadcast to the viewing audience, making it available on a variety of devices. The subscription service also provides the ability to detect the viewers' bandwidth and computing capacity to adjust the quality of the video stream accordingly, making for a better viewing experience. This solution will apply to viewers that are

external to the County network; at this time the internal County users will continue to use the existing solution.

The estimated project total is \$27,283.25 and includes the following:

- Hardware needed to capture the Metro Cable 14 Broadcast feed to be sent out to the subscription service.
- Subscription service for the first year of the streaming service.
- Hours needed for installation, configuration and management of the project.

Thank you for the information on your planned budget recommendation to the SMCTC members. We are pleased about your 4% COLA offer and on the recommendation to fully fund the HD truck in one year.

Based on our discussion this morning, I have revised our operational budget request by reducing from a 5% Cost of Living adjustment to a 4% request. I have left in the specific supplemental requests for permanent augmentations for minimum wage and payroll benefits allocations.

On the PEG fee side, I have implemented the two changes we discussed. I have added the sales tax to the HD truck, and reduced the other items by \$84,295. You asked for \$80,000. The attached PEG FEE Fund One-Time Equipment Request list marks the reductions in three specified line items in red.

We have removed the network infrastructure in the digital media lab and reduced the number of computers in item #1. We cut the number of cameras requested from four to two in item #13. We eliminated item #14, a replay system for the existing SD truck (and will use existing checkout systems) as a temporary fix. These items likely would resurface as top items in 2016-17.

Dear Mr. Davison & Sacramento Metropolitan Cable Television Commissioners,

Each year since 1989, the Sacramento Metropolitan Cable Television Commission has provided substantial annual support to Capital Public Radio. Your financial commitment continues to support the quality and diversity of programs and services that we are able to bring every day to the greater Sacramento community.

As you may know, Capital Public Radio started as a single station in 1979, and today is a sevenstation network broadcasting to more than 450,000 listeners each week and an ever-increasing global audience through the Internet. Essential to our everyday lives, Capital Public Radio enriches the experience of listeners in the Sacramento region through engaging discussions, lively debates, cutting-edge multimedia arts programs, and inspiring classical and jazz music.

In addition to signature programs such as Morning Edition, All Things Considered, Fresh Air, Marketplace and Car Talk from NPR, American Public Media and Public Radio International, Capital Public Radio has its own award winning news department and produces its own daily public affairs program, Insight. On the music side, Capital Public Radio offers locally originated classical, jazz, and blues music each week including Excellence in Jazz, Mick Martin's Blues Party, and At the Opera with Sean Bianco.

#### Highlights from this past year include:

Food and Sustainability Reporter: As part of the station's Food and Sustainability
initiative - Healthy Eating. Healthy Communities. Building a Sustainable Future., reporter
Lesley McClurg was hired in January 2015. An award winning reporter from Denver
Colorado, she will examine the impact of food and agriculture in our region. She will
report on food as it relates to the environment, health, culture, policy and the changing
demographics of California. She will identify innovation and trends, and connect what's
happening in this region with the rest of California and the world.



- CapRadio Garden: Construction of CapRadio Garden at Sac State literally in the station's back yard, began in October 2014. The garden hard-scape has been completed and the first spring planting is underway. Beehives have been installed along with 80,000 bees.
   Streaming of the hives will be available on our website and to select schools for science education in the coming year.
- We broadcast our latest award winning documentary, The View From Here: "Hidden Hunger" in December 2014. This documentary brought first-person stories of people coping with food insecurity in one of the country's richest agricultural regions. "Hidden Hunger" explores the daily struggles of children, adults and seniors who live in overlooked neighborhoods of south Sacramento, where the stigma of poverty and hunger is high. The project raises awareness of the challenges facing those who live in the these food deserts and examines local solutions to alleviate hunger. Portions of this documentary were also broadcast on NPR.
- Capital Public Radio launched CapRadioMusic a reorganization of the music stations and the launch of the music side of the CapRadio website. After several months of exploration and strategic planning, a transition plan is in place and will be implemented starting May 1, 2015.
- Capital Public Radio is the recipient three Edward R Murrow Awards, just announced for 2014/2015:
  - News Documentary: The View From Here: Hidden Hunger (TVFH Documentary Unit)
  - 2. Ongoing Coverage: State of Drought (Entire News Dept)
  - 3. Sports Reporting: Soccer Team's Goal: Show Sacramento Belongs In The Major Leagues (Sacramento Region Reporter, Bob Moffitt)

#### Plans for fiscal year 2015-2016 include:

- The View From Here: Undocumented Immigrants project including The View From Here documentary unit, the entire News Team and community partners.
- Garden Project: Implementation of the volunteer program for planting and maintenance; Mobile Food Truck & education components in select schools; Lunch & Learn Outdoor Kitchen with UC Davis.
- Complete a Planning Study and implement a Capital Campaign (\$10-\$15 million) for station expansion, facility remodel, and transmitter upgrades. Planning Study will be completed in Fall 2015 with the first phase of the Capital Campaign immediately following.
- Construction of the KXPR Tower near the Sacramento County Landfill: Seven years in the making, the KCPR Tower Project is finally in the last stages of approval. Construction is expected in Fall 2015 or Spring 2016 depending on weather and Swainson's Hawk nesting issues, and will be located near the Sacramento Landfill on Kiefer Road.
- Install infrastructure upgrades for digital audio equipment to provide greater reliability and cost savings in the primary News and Production Studio in Fall 2015.



Annual funding from the Sacramento Metro Cable Television Commission helps Capital Public Radio to proudly provide, not only the very best in NPR programming, but also includes:

- ♦ 24 hour music programming including daily classical music, evening jazz and local music programs such as *Excellence in Jazz*, and *At the Opera with Sean Bianco*, a weekly locally hosted show providing opera music and educational commentary.
- Our award winning, locally produced daily news reports.
- Our award winning, locally produced documentaries.
- Our locally produced and innovative daily public affairs program, *Insight* with host, Beth Ruyak.
- Our Capitol News Bureau and the Capital Public Radio Network, an innovative and wellrespected news bureau that covers both the state legislature and local government providing reports to more than 50 stations in California, Southern Oregon, and Western Nevada.
- ◆ Locally produced music programs like Mick Martin's Blues Party, Blue Dog Jam, Acid Jazz, Connections; and
- 24 hour online streaming of Jazz and Classical Music in additional to streaming our regular broadcasts.

In order to maintain our local programming at the current level, Capital Public Radio is requesting a grant in the amount of \$18,233 from the Sacramento Metropolitan Cable Television Commission for general operations.

The request for funding for general operations will support the following services:

Approximately 6% of our music programming personnel cost including Excellence in Jazz, Mick Martin's Blues Party (weekly four hour show), Blue Dog Jam with Nick Brunner (weekly four hour show of AAA and Indie music including local bands) and At the Opera with Sean Bianco (weekly four hour show).

In addition to the general operation request, Capital Public Radio is a requesting support for a **one-time equipment purchase** in the amount of **\$8,226**.

With the ongoing growth of Capital Public Radio and the planned expansion of our facilities, there is a strong practical and business need to design a broadcast audio infrastructure that provides greater reliability and cost savings compared to the analog systems currently in place in our studios today.

The equipment requested is from Axia Audio, the studio audio division of Telos Alliance, the leader in audio-over-IP for broadcasting. The foundational technology in all Axia products enables high reliability, low delay uncompressed digital audio over Ethernet.



In practical terms, this means getting away from walls of wiring and punch blocks to neat high-density Ethernet mixing engines to power the CapRadio broadcast infrastructure. Devices connect together using standard Ethernet cables and audio routing is accomplished with off-the-shelf Ethernet switches. The lower cost of entry will also allow us to build a redundant system to act as a failsafe that keeps us on the air should the primary router fail.

Total request for funding is \$26,459 (\$18,233 general operations and \$8,226 one time equipment).

Capital Public Radio has delivered superior-quality news and music programming to Northern California for more than 35 years. Capital Public Radio is a private, nonprofit, community based organization, and we are affiliated with California State University, Sacramento (Sac State). However, it is important to note, we don not receive any funding from Sac State.

As part of our recognition for your support, the Sacramento Metropolitan Cable Television Commission is acknowledged a minimum of once per month on our stations, 90.9 FM and 88.9 FM and is linked on our website, capradio.org.

On behalf of all of us at Capital Public Radio, I wish to express my appreciation for the many years of faith you have placed in us, and for this opportunity to request your continued support.

#### Dear Commission Members:

Thank you for your continuing generosity so that we are able to serve the residents of Sacramento County with quality, non-commercial educational programming available on the most-accessible tier for cable subscribers.

The grant that KVIE receives from SMCTC continues to be one of our largest annual grants and helps us fulfill our goal of producing and delivering quality programming that delights our viewers.

In previous years, we have been able to forgo our general fund operations grant and seek solely funds from the 1% PEG fee. Because of the continued slow economic recovery and its affect on non-profits like KVIE in addition to our previous requests that have helped to grow our capital budget, we are requesting the base operations grant of \$199,417 along with a one-time PEG equipment grant of \$371,813.43 for a total of \$571,230.43.

These requests will support operating costs and target specific needs for facilities, program production, signal delivery, network infrastructure and quality control that will positively impact our KVIE2 service.

#### **Facilities**

With the new HVAC units we have acquired through the PEG funding, we now need to upgrade our HVAC control system because parts are no longer available. In addition, we need to repair the hot water valves in the HVAC units. The cost is \$33,338.

In order to provide community screenings of our productions, we propose to repair and re-skin the movable wall partitions in our Ose Community Room and also install a video projector. The total cost for these items is \$19,769.92.

#### **Production/Content Creation**

We propose to add a location lighting kit, small cameras and microphones and camera lock boxes to our field production equipment. This will increase our productivity and equipment security in the field. The cost is \$15,463.51.

We propose to streamline our quality control process of our video productions. Our Aurora file verification hardware and software will work with our new transcoding software to verify the integrity of our post-production content. It will work continually in the background, analyzing files as they are produced and will alert us if a file has a problem. The cost is \$25,291.69.

#### **Signal Delivery**

We need to ensure our encoders are working properly, as well as troubleshoot them when they are not. The Tektronix MTS 4000 is a comprehensive digital analyzer that we would like to purchase. It will also help us troubleshoot closed caption problems, which the FCC is continuing to put tighter restrictions on. It is compatible with the test equipment we already have. The cost is \$64,807.05.

We propose to replace our analog sync generator system with a new system with seamless failover. The master sync generator system supplies the timing signals necessary for our production and signal delivery equipment. The system cost is \$38,617.50.

At times, we need to bypass our master control switching system. This happens when we need to troubleshoot an equipment problem or when we upgrade switcher and automation software. This is done with a small external switcher. In troubleshooting, we generally take the programming stream to bypass because it frees all switching and automation systems. The switcher we presently use for this task is not capable of what is called a "clean-quiet switch" or "CQS". Rather, it performs a "glitch switch," which as the name implies, glitches the program stream. This causes the encoders and then the viewers' sets at home to unlock momentarily—meaning the TV set goes to black. We propose to replace the glitch switcher with a CQS system that will not glitch the programs. The cost for this system is \$43,400.

We still have outdated analog black and white CRT monitors in our tape racks. We propose to replace these with LCD monitors. The cost is \$2,140.89.

We propose to update the production SAN (storage area network) that support our production editors in their video creation with an M445D Metadata Controller Appliance. The cost is \$87,559.50.

#### **Network Facilities**

We propose various network facility and hardware upgrades that include replacement of the domain controllers, update and addition of virtual and exchange servers, management software and AutoCAD LT software, which we will use in design and documentation. The cost for these projects is \$41,325.37.

Per Karen's request, attached is the Sacramento Educational Cable Consortium's (SECC) and BESTNet 2015-2016 Budget and One Time PEG Fee Funding request.

SECC is requesting \$408,114 in funding from the SMCTC PEG Fee and General Funds. Specifically:

- \$105,000 in one time PEG Facilities and Equipment funding
- \$43,758 for SECC general operations (part of operational grant) from PEG Fee Fund
- **\$259,356** from the General fund (**SECC operational grant**) to supplement the SECC budget. Note: SECC generates approximately \$230,000 in additional general operations revenue.

#### BESTNet is requesting:

- \$600,000 for Phase 3 School Connections from the PEG Fee
- \$56,976 from the general fund for operations

#### ONE TIME PEG FEE FUND REQUEST

- \$15,000 To update and upgrade 10-year-old SECC production equipment.
- \$90,000 SEVA Studio Labs "match" for student/teacher media facilities at sites to be determined once funding is secured.

Each SEVA site will provide programming produced by students for the educational channels to enhance the educational offerings to Sacramento.

It is proven that the production process engages and motivates students and, with the implementation of the Common Core State Standards (CCSS), Sacramento's generation of learners will need to communicate even more using technology. The proposed SEVA Studio Labs will enhance Sacramento students' educational experiences by integrating these skills into the classroom curriculum.

The SEVA Studio Labs also expands SECC's SEVA program (Student Educational Video Awards, now in its 26<sup>th</sup> year) that joins students, teachers and businesses and provides extensive training and assistance to Sacramento county schools. The program's objective has always been to enhance academic achievement while students learn to work collaboratively in teams and engage in projects that motivate them to remain in school.

SECC is requesting \$90,000 to create multiple SEVA Studio Labs in schools/districts that demonstrate a viable interest in implementing or expanding media programs. The proposed identification/selection process will be:

- 1. When funding amount is approved by the SMCTC in June, SECC will announce to the Board that funds are available and establish a timeline for fall projects and spring projects (funding from SMCTC is divided into two payments.) Districts will work with their SECC Board Representative to provide recommendations of potential sites from their districts.
- 2. SECC staff will work with each potential site to determine equipment needs based on individual site and staffing, potential school and district dollars. A detailed budget aligning with available SMCTC, school and district funds will be established for SECC Board approval and submission to the SMCTC staff. The SECC Board will make final decisions on sites to be developed and the order in which the sites will be implemented.

SECC member districts and school sites are committed to this project and will assist with installation, facilities, maintenance, program and curriculum development and ongoing program support.

These labs, as described below, will create additional programming content on the educational channels as well as growing the SEVA program which has provided countless hours of student-produced content for the Sacramento community.

#### Studio

The studio setup in this proposal would support, in addition to school productions, a daily morning news show scenario. Three HD camcorders are tethered to an entry

level HD/SD Newtek Tricaster unit. The Tricaster offers in one box professional level live switching, character generation, video playback, audio mixing and final output recording. Simple to operate by students and teachers, the system uses extensive green screen technology to place the talent in virtual sets. A series of efficient fluorescent lights illuminate two different green screen backdrop systems – one for the fixed talent and one for walk-ons. Audio is a mix of wireless and wired audio solutions for anchors and walk-on talent. Two of the cameras have a teleprompter to help on-camera talent deliver information smoothly and efficiently.

#### Field Kits

Based on SECC's previous DV Starter Kits, each lab kit includes a compact HD camcorder shooting H264, a UHF wireless mic setup, video tripod, spare battery, headphones and protective camera case. Five kits are included in this proposal.

#### **Computers**

Apple iMac computers with Adobe Premiere Elements and Photoshop software would serve as edit stations for packages/stories shot by the field kit units. The completed stories would be sent over the network to the Tricaster unit for inclusion in the morning program.

#### District/School Match: Facility/Maintenance/Installation

The districts and schools are committed to these labs and will contribute facilities, installation, maintenance and resources to the program.

#### **BESTNet: \$600,000 PEG Funding:**

The BESTNet Phase 3 Elementary School build continues to be one year behind, and therefore, there are funds encumbered by the SMCTC that have been carried over into subsequent years. Comcast is currently working on Year 4 schools that will be completed by 2015 Year End. Year 3 and 4 funds have been encumbered by SMCTC and the School Districts, but have not been received by SECC and carried over for expenditure in 2015-2016.

#### SECC OPERATIONS

(Budget specifics are attached)

2014-2015 was a pivotal year for SECC. There has been a major shift in the use of the educational channels, and local production and educational promotion and communication within the membership has greatly increased. SECC members continue to explore new ways of utilizing the channels to reach students, parents and the community. Therefore, SECC is examining and modifying staffing needs to reflect and meet the needs of a changing educational environment. Through ongoing partnerships, efficiencies and creative expenditures SECC is proposing the attached conservative 2015-2016 budget that includes:

• A decrease in funding from outside sources (specifically grants)

- Estimate of carryover funds from 2014-2015
- Modifications in staffing based on decreased funding and changing needs
- Modifications and an increase in production expenditures directly related to grant funding
- Full time (24/7) operation of the educational channels focused on locally produced content and educational content geared specifically for Sacramento community.

SECC leverages funds from the SMCTC to supplement the operations of the educational channels. The total 2015-2016 SECC operational budget is \$639,918 of which \$408,314 is requested from the SMCTC. The \$231,504 balance is generated by the SECC membership.

#### BESTNet Operations: \$56,976 from the general fund

# Annual Investment Policy of the Pooled Investment Fund

CALENDAR YEAR 2015

#### I. Authority

Under the Sacramento County Charter, the Board of Supervisors established the position of Director of Finance and by ordinance will annually review and renew the Director of Finance's authority to invest and reinvest all the funds in the County Treasury.

#### II. Policy Statement

This Investment Policy (Policy) establishes cash management and investment guidelines for the Director of Finance, who is responsible for the stewardship of the Sacramento County Pooled Investment Fund. Each transaction and the entire portfolio must comply with California Government Code and this Policy. All portfolio activities will be judged by the standards of the Policy and its investment objectives. Activities that violate its spirit and intent will be considered contrary to the Policy.

#### III. Standard of Care

The Director of Finance is the Trustee of the Pooled Investment Fund and therefore, a fiduciary subject to the prudent investor standard. The Director of Finance, employees involved in the investment process, and members of the Sacramento County Treasury Oversight Committee (Oversight Committee) shall refrain from all personal business activities that could conflict with the management of the investment program. All individuals involved will be required to report all gifts and income in accordance with California state law. When investing, reinvesting, purchasing, acquiring, exchanging, selling and managing public funds, the Director of Finance shall act with care, skill, prudence, and diligence to meet the aims of the investment objectives listed in Section IV, Investment Objectives.

#### IV. Investment Objectives

The Pooled Investment Fund shall be prudently invested in order to earn a reasonable return, while awaiting application for governmental purposes. The specific objectives for the Pooled Investment Fund are ranked in order of importance.

#### A. Safety of Principal

The preservation of principal is the primary objective. Each transaction shall seek to ensure that capital losses are avoided, whether they be from securities default or erosion of market value.

#### **B.** Liquidity

As a second objective, the Pooled Investment Fund should remain sufficiently flexible to enable the Director of Finance to meet all operating requirements that may be reasonably anticipated in any depositor's fund.

#### C. Public Trust

In managing the Pooled Investment Fund, the Director of Finance and the authorized investment traders should avoid any transactions that might impair public confidence in Sacramento County and the participating local agencies. Investments should be made with precision and care, considering the probable safety of the capital as well as the probable income to be derived.

#### D. Maximum Rate of Return

As the fourth objective, the Pooled Investment Fund should be designed to attain a market average rate of return through budgetary and economic cycles, consistent with the risk limitations, prudent investment principles and cash flow characteristics identified herein. For comparative purposes, the State of California Local Agency Investment Fund (LAIF) will be used as a performance benchmark. The Pooled Investment Fund quarterly performance benchmark target has been set at or above LAIF's yield. This benchmark was chosen because LAIF's portfolio structure is similar to the Pooled Investment Fund.

#### V. Pooled Investment Fund Investors

The Pooled Investment Fund investors are comprised of Sacramento County, school and community college districts, districts directed by the Board of Supervisors, and independent special districts whose treasurer is the Director of Finance. Any local agencies not included in this category are subject to California Government Code section 53684 and are referred to as outside investors.

#### VI. Implementation

In order to provide direction to those responsible for management of the Pooled Investment Fund, the Director of Finance has established this Policy and will provide it to the Oversight Committee and render it to legislative bodies of local agencies that participate in the Pooled Investment Fund. In accordance with California Government Code section 53646, et seq., the Board of Supervisors shall review and approve this Policy annually.

This Policy provides a detailed description of investment parameters used to implement the investment process and includes the following: investable funds; authorized instruments; prohibited investments; credit requirements; maximum maturities and concentrations; repurchase agreements; Community Reinvestment Act Program; criteria and qualifications of broker/dealers and direct issuers; investment guidelines, management style and strategy; Approved Lists; and calculation of yield and costs.

#### VII. Internal Controls

The Director of Finance shall establish internal controls to provide reasonable assurance that the investment objectives are met and to ensure that the assets are protected from loss, theft, or misuse. To assist in implementation and internal controls, the Director of Finance has established an Investment Group and a Review Group.

The Investment Group, which is comprised of the Director of Finance and his/her designees, is responsible for maintenance of the investment guidelines and Approved Lists. These guidelines and lists can be altered daily, if needed, to adjust to the ever-changing financial markets. The guidelines can be more conservative or match the policy language. In no case can the guidelines override the Policy.

The Review Group, which is comprised of the Director of Finance and his/her designees, is responsible for the monthly review and appraisal of all the investments purchased by the Director of Finance and staff. This review includes bond proceeds, which are invested separately from the Pooled Investment Fund and are not governed by this Policy.

The Director of Finance shall establish a process for daily, monthly, quarterly, and annual review and monitoring of the Pooled Investment Fund activity. The following articles, in order of supremacy, govern the Pooled Investment Fund:

- 1. California Government Code
- 2. Annual Investment Policy
- 3. Current Investment Guidelines
- 4. Approved Lists (see page 9, Section IX.K)

The Director of Finance shall review the daily investment activity and corresponding bank balances.

Monthly, the Review Group shall review all investment activity and its compliance to the corresponding governing articles and investment objectives.

Quarterly, the Director of Finance will provide the Oversight Committee with a copy of the Pooled Investment Fund activity and its compliance to the annual Policy and California Government Code.

Annually, the Oversight Committee shall cause an annual audit of the activities within the Pooled Investment Fund to be conducted to determine compliance to the Policy and California Government Code. This audit will include issues relating to the structure of the investment portfolio and risk.

All securities purchased, with the exception of time deposits, money market mutual funds, LAIF and Wells Fargo's overnight investment fund, shall be delivered to the independent third-party custodian selected by the Director of Finance. This includes all collateral for repurchase agreements. All trades, where applicable, will be executed by delivery versus payment by the designated third-party custodian.

#### VIII. Sacramento County Treasury Oversight Committee

In accordance with California Government Code section 27130 et seq., the Board of Supervisors, in consultation with the Director of Finance, has created the Sacramento County Treasury Oversight Committee (Oversight Committee). Annually, the Director of Finance shall prepare an Investment Policy that will be forwarded to and monitored by the Oversight Committee and rendered to Boards of all local agency participants. The Board of Supervisors shall review and approve the Policy during public session. Quarterly, the Director of Finance shall provide the Oversight Committee a report of all investment activities of the Pooled Investment Fund to ensure compliance to the Policy. Annually, the Oversight Committee shall cause an audit to be conducted on the Pooled Investment Fund. The meetings of the Oversight Committee shall be open to the public and subject to the Ralph M. Brown Act.

A member of the Oversight Committee may not be employed by an entity that has contributed to the campaign of a candidate for the office of local treasurer, or contributed to the campaign of a candidate to be a member of a legislative body of any local agency that has deposited funds in the county treasury, in the previous three years or during the period that the employee is a member of the Oversight Committee. A member may not directly or indirectly raise money for a candidate for local treasurer or a member of the Sacramento County Board of Supervisors or governing board of any local agency that has deposited funds in the county treasury while a member of the Oversight Committee. Finally, a member may not secure employment with, or be employed by bond underwriters, bond counsel, security brokerages or dealers, or financial services firms, with whom the treasurer is doing business during the period that the person is a member of the Oversight Committee or for one year after leaving the committee.

The Oversight Committee is not allowed to direct individual investment decisions, select individual investment advisors, brokers or dealers, or impinge on the day-to-day operations of the Department of Finance treasury and investment operations.

#### IX. Investment Parameters

#### A. Investable Funds

Total Investable Funds (TIF) for purposes of this Policy are all Pooled Investment Fund moneys that are available for investment at any one time, including the estimated bank account float. Included in TIF are funds of outside investors, if applicable, for which the Director of Finance provides investment services. Excluded from TIF are all bond proceeds.

The Cash Flow Horizon is the period in which the Pooled Investment Fund cash flow can be reasonably forecasted. This Policy establishes the Cash Flow Horizon to be one (1) year.

Once the Director of Finance has deemed that the cash flow forecast can be met, the Director of Finance may invest funds with maturities beyond one year. These securities will be referred to as the Core Portfolio.

#### **B.** Authorized Investments

Authorized investments shall match the general categories established by the California Government Code sections 53601 et seq. and 53635 et seq. Authorized investments shall

include, in accordance with California Government Code section 16429.1, investments into LAIF. Authorization for specific instruments within these general categories, as well as narrower portfolio concentration and maturity limits, will be established and maintained by the Investment Group as part of the Investment Guidelines. As the California Government Code is amended, this Policy shall likewise become amended.

#### C. Prohibited Investments

No investments shall be authorized that have the possibility of returning a zero or negative yield if held to maturity. These shall include inverse floaters, range notes, and interest only strips derived from a pool of mortgages.

All legal investments issued by a tobacco-related company are prohibited. A tobacco-related company is defined as an entity that makes smoking products from tobacco used in cigarettes, cigars, or snuff or for smoking in pipes. The tobacco-related issuers restricted from any investment are any component companies in the Dow Jones U.S. Tobacco Index or the NYSE Arca Tobacco Index. Annually the Director of Finance and/or his designee will update the list of tobacco-related companies.

#### D. Credit Requirements

Except for municipal obligations and Community Reinvestment Act (CRA) bank deposits and certificates of deposit, the issuer's short-term credit ratings shall be at or above A-1 by Standard & Poor's, P-1 by Moody's, and, if available, F1 by Fitch, and the issuer's long-term credit ratings shall be at or above A by Standard & Poor's, A2 by Moody's, and, if available, A by Fitch. There are no credit requirements for Registered State Warrants. All other municipal obligations shall be at or above a short-term rating of SP-1 by Standard & Poor's, MIG1 by Moody's, and, if available, F1 by Fitch. In addition, domestic banks are limited to those with a Fitch Viability rating of a or better, without regard to modifiers. The Investment Group is granted the authority to specify approved California banks with Fitch Viability ratings of bbb+ but they must have a Support rating of 1 where appropriate. Foreign banks with domestic licensed offices must have a Fitch Sovereign rating of AAA and a Fitch Viability rating of a or better, without regard to modifiers; however, a foreign bank may have a rating of bbb+ but they must have a Support rating of 1. Domestic savings banks must be rated a or better, without regard to modifiers, or may have a rating of bbb+ but they must a Support rating of 1.

Eligible banks must have Community Reinvestment Act performance ratings of "satisfactory" or "outstanding" from each financial institution's regulatory authority. In addition, deposits greater than the federally-insured amount must be collateralized. Banks must place securities worth between 110% and 150% of the value of the deposit with the Federal Reserve Bank of San Francisco, the Home Loan Bank of San Francisco, or a trust bank.

Since credit unions do not have Community Reinvestment Act performance ratings, they must demonstrate their commitment to meeting the community reinvestment lending and charitable activities, which are also required of banks.

All commercial paper and medium-term note issues must be issued by corporations operating within the United States and having total assets in excess of one billion dollars (\$1,000,000,000).

The Investment Group may raise these credit standards as part of the Investment Guidelines and Approved Lists. Appendix A provides a Comparison and Interpretation of Credit Ratings by Standard & Poor's, Moody's, and Fitch.

#### E. Maximum Maturities

Due to the nature of the invested funds, no investment with limited market liquidity should be used. Appropriate amounts of highly-liquid investments, such as Treasury and Agency securities, should be maintained to accommodate unforeseen withdrawals.

The maximum maturity, determined as the term from the date of ownership to the date of maturity, for each investment shall be established as follows:

The Investment Group may reduce these maturity limits to a shorter term as part of the Investment Guidelines and the Approved Lists.

The ultimate maximum maturity of any investment shall be five (5) years. The dollar-weighted average maturity of all securities shall be equal to or less than three (3) years.

#### F. Maximum Concentrations

No more than 80% of the portfolio may be invested in issues other than United States Treasuries and Government Agencies. The maximum allowable percentage for each type of security is set forth as follows:

The Investment Group may reduce these concentrations as part of the Investment Guidelines and the Approved Lists.

No more than 10% of the portfolio, except Treasuries and Agencies, may be invested in securities of a single issuer including its related entities.

Where a percentage limitation is established above, for the purpose of determining investment compliance, that maximum percentage will be applied on the date of purchase.

#### G. Repurchase Agreements

Under California Government Code section 53601, paragraph (j) and section 53635, the Director of Finance may enter into Repurchase Agreements and Reverse Repurchase Agreements. The maximum maturity of a Repurchase Agreement shall be one year. The maximum maturity of a reverse repurchase agreement shall be 92 days, and the proceeds of a reverse repurchase agreement may not be invested beyond the expiration of the agreement. The reverse repurchase agreement must be "matched to maturity" and meet all other requirements in the code.

All repurchase agreements must have an executed Sacramento County Master Repurchase Agreement on file with both the Director of Finance and the Broker/Dealer. Repurchase Agreements executed with approved broker-dealers must be collateralized with either: (1) U.S. Treasuries or Agencies with a market value of 102% for collateral marked to market daily; or (2) money market instruments which are on the Approved Lists of the County and which meet the qualifications of the Policy, with a market value of 102%. Since the market value of the underlying securities is subject to daily market fluctuations, investments in repurchase agreements shall be in compliance if the value of the underlying securities is brought back up to 102% no later than the next business day. Use of mortgage-backed securities for collateral is not permitted. Strictly for purposes of investing the daily excess bank balance, the collateral provided by the Sacramento County's depository bank can be Treasuries or Agencies valued at 110%, or mortgage-backed securities valued at 150%.

#### H. Community Reinvestment Act Program

The Director of Finance has allocated within the Pooled Investment Fund, a maximum of \$90 million for the Community Reinvestment Act Program to encourage community investment by financial institutions, which includes community banks and credit unions, and to acknowledge and reward local financial institutions which support the community's financial needs. The Director of Finance may increase this amount, as appropriate, while staying within the investment policy objectives and maximum maturity and concentration limits. The eligible banks and savings banks must have Community Reinvestment Act performance ratings of "satisfactory" or "outstanding" from each financial institution's regulatory authority. The minimum credit requirements are located on page 5 of Section IX.D.

#### I. Criteria and Qualifications of Brokers/Dealers and Direct Issuers

All transactions initiated on behalf of the Pooled Investment Fund and Sacramento County shall be executed through either government security dealers reporting as primary dealers to the Market Reports Division of the Federal Reserve Bank of New York or direct issuers that directly issue their own securities which have been placed on the Approved List of

brokers/dealers and direct issuers. Further, these firms must have an investment grade rating from at least two national rating services, if available.

Brokers/Dealers and direct issuers which have exceeded the political contribution limits, as contained in Rule G-37 of the Municipal Securities Rulemaking Board, within the preceding four-year period to the Director of Finance, any member of the Board of Supervisors, or any candidate for the Board of Supervisors, are prohibited from the Approved List of brokers/dealers and direct issuers.

Each broker/dealer and direct issuer will be sent a copy of this Policy and a list of those persons authorized to execute investment transactions. Each firm must acknowledge receipt of such materials to qualify for the Approved List of brokers/dealers and direct issuers.

Each broker/dealer and direct issuer authorized to do business with Sacramento County shall, at least annually, supply the Director of Finance with audited financial statements.

#### J. Investment Guidelines, Management Style and Strategy

The Investment Group, named by the Director of Finance, shall issue and maintain Investment Guidelines specifying authorized investments, credit requirements, permitted transactions, and issue maturity and concentration limits which are consistent with this Policy.

The Investment Group shall also issue a statement describing the investment management style and current strategy for the entire investment program. The management style and strategy can be changed to accommodate shifts in the financial markets, but at all times they must be consistent with this Policy and its objectives.

#### K. Approved Lists

The Investment Group, named by the Director of Finance, shall issue and maintain various Approved Lists. These lists are:

- 1. Approved Domestic Banks for all legal investments.
- 2. Approved Foreign Banks for all legal investments.
- 3. Approved Commercial Paper and Medium Term Note Issuers.
- 4. Approved Money Market Mutual Funds.
- 5. Approved Firms for Purchase or Sale of Securities (Brokers/Dealers and Direct Issuers).
- 6. Approved Banks / Credit Unions for the Community Reinvestment Act Program.

#### L. Calculation of Yield and Costs

The costs of managing the investment portfolio, including but not limited to: investment management; accounting for the investment activity; custody of the assets; managing and accounting for the banking; receiving and remitting deposits; oversight controls; and indirect and overhead expenses are charged to the investment earnings based upon actual labor hours worked in respective areas. Costs of these respective areas are accumulated by specific cost

accounting projects and charged to the Pooled Investment Fund on a quarterly basis throughout the fiscal year.

The Department of Finance will allocate the net interest earnings of the Pooled Investment Fund quarterly. The net interest earnings are allocated based upon the average daily cash balance of each Pooled Investment Fund participant.

#### X. Reviewing, Monitoring and Reporting of the Portfolio

The Review Group will prepare and present to the Director of Finance at least monthly a comprehensive review and evaluation of the transactions, positions, performance of the Pooled Investment Fund and compliance to the California Government Code, Policy, and Investment Guidelines.

Quarterly, the Director of Finance will provide to the Oversight Committee and to any local agency participant that requests a copy, a detailed report on the Pooled Investment Fund. Pursuant to California Government Code section 53646, the report will list the type of investments, name of issuer, maturity date, par and dollar amount of the investment. For the total Pooled Investment Fund, the report will list average maturity, the market value, and the pricing source. Additionally, the report will show any funds under the management of contracting parties, a statement of compliance to the Policy and a statement of the Pooled Investment Fund's ability to meet the expected expenditure requirements for the next six months.

Each quarter, the Director of Finance shall provide to the Board of Supervisors and interested parties a comprehensive report on the Pooled Investment Fund.

Annually, the Director of Finance shall provide to the Oversight Committee the Investment Policy. Additionally, the Director of Finance will render a copy of the Investment Policy to the legislative body of the local agencies that participate in the Pooled Investment Fund.

#### XI. Withdrawal Requests for Pooled Fund Investors

The Director of Finance will honor all requests to withdraw funds for normal cash flow purposes that are approved by the Director of Finance at a one dollar net asset value. Any requests to withdraw funds for purposes other than immediate cash flow needs, such as for external investing, are subject to the consent of the Director of Finance. In accordance with California Government Code Sections 27133(h) and 27136, such requests for withdrawals must first be made in writing to the Director of Finance. When evaluating a request to withdraw funds, the Director of Finance will take into account the effect of a withdrawal on the stability and predictability of the Pooled Investment Fund and the interests of other depositors. Any withdrawal for such purposes will be at the market value of the Pooled Investment Fund on the date of the withdrawal.

#### XII. Limits on Honoraria, Gifts, and Gratuities

In accordance with California Government Code Section 27133(d), this Policy establishes limits for the Director of Finance; individuals responsible for management of the portfolios; and members of the Investment Group and Review Group who direct individual investment decisions, select individual investment advisors and broker/dealers, and conduct day-to-day investment

trading activity. The limits also apply to members of the Oversight Committee. Any individual who receives an aggregate total of gifts, honoraria and gratuities in excess of \$50 in a calendar year from a broker/dealer, bank or service provider to the Pooled Investment Fund must report the gifts, dates and firms to the designated filing official and complete the appropriate State forms.

No individual may receive aggregate gifts, honoraria, and gratuities in a calendar year in excess of the amount specified in Section 18940.2(a) of Title 2, Division 6 of the California Code of Regulations. This limitation was \$440 for the period January 1, 2013, to December 31, 2014. Any violation must be reported to the State Fair Political Practices Commission.

#### XIII. Terms and Conditions for Outside Investors

Outside investors may invest in the Pooled Investment Fund through California Government Code Section 53684. Their deposits are subject to the consent of the Director of Finance. The legislative body of the local agency must approve the Sacramento County Pooled Investment Fund as an authorized investment and execute a Memorandum of Understanding. Any withdrawal of these deposits must be made in writing 30 days in advance and will be paid based upon the market value of the Pooled Investment Fund. If the Director of Finance considers it appropriate, the deposits may be returned at any time to the local agency.
