Brian Weitzel, the Video Production and Broadcasting teacher at Del Campo High School thanked the Cable Commission for the SEVA lab grant, which resulted in the implementation of a TV studio at Del Camp High. A video was shown of students working in the studio.

David Lowe, President of KVIE thanked the Board for the approving the PEG equipment funding for the new fiscal year. A video showcasing the use of PEG equipment approved in past years was shown; a clip of Ken Burns' special on the Vietnam War was also shown. The Vietnam War special will premiere on September 17, 2017; the PR material will be disseminated to staff when available.

Gary Martin, Executive Director for Access Sacramento announced that have a new Board chair; Access Sacramento will host the ACM western state regional conference which will be held in March 2018 at the Embassy Suites. Gary invited the Board to tour the Coloma Center, which houses new PEG equipment that have been purchased.
